RESOLVED AT THE MEETING OF DIRECTORS HELD ON 25TH FEBRUARY 2021 THAT:

- 1. In respect of the R70 million loan from the With-Profit Policyholder Fund to the Shareholder Fund drawn on 21/01/2021 by Management as approved by the Investment Committee of the Board of Directors and later ratified by the Board:
 - (a) The loan accrues interest quarterly at a rate of the 3-month Johannesburg Inter-Bank Acceptance Rate plus 2%;
 - (b) That the loan is repayable with all accrued interest by 31 December 2021; and
 - (c) The above terms are subject to the approval of the Head of the Actuarial Function ("HAF").
- 2. In respect of future instances where the With-Profit Policyholder Fund is to considered for funding, the following processes need to be followed:
 - (a) Assessment of the recoverability of the proposed loan funding, linked to an Own Risk and Solvency Projections ("ORSA") performed in terms of the Company's ORSA policy;
 - (b) A proposal of the terms of the loan (interest rates applicable and repayment terms);
 - (c) The impact on With-Profit Policyholder benefits in event that the loan, together with any outstanding loan balances by the Shareholder Fund to the With-Profit Policyholder Fund is not recoverable;
 - (d) The opinion of the HAF on the terms and recoverability of the loan as well as the impact on With-Profit Policyholder benefits in the event that the advances loans are not recoverable; and
 - (e) The recommendation of the Investment Committee to the Board with respect to the proposed loan.
