HAVING HEARD COUNSEL FOR THE CITY OF CAPE TOWN AND GOLDEN ARROW BUS SERVICES (PTY) LTD, it is ordered that:

1. The application is heard on an urgent basis and the rules relating to the periods for service and filing are dispensed with.
2. The City of Cape Town is joined as the second applicant in application 13356/2023.
3. Pending the determination of the hearing on 23 August 2023, it is ordered that:
 - 3.1. no person, vehicle, taxi or driver may unreasonably obstruct, interfere or block any vehicle on any public road, throughout the City Metropole, in such manner as to harm passengers, or delay or impede the flow of traffic.
 - 3.2. no person may approach, within 100 meters, any transportation depot throughout the Cape Metropole, and no person may interfere with the operations of any transportation depot.
4. Any person affected by this order may anticipate the order and approach the Court within 24 hours' notice.
5. There is no order as to costs.
